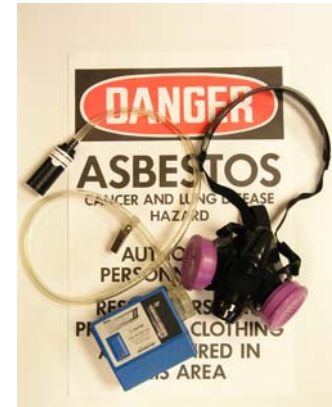

It is a well know fact that the improper removal of asbestos containing material can be much more dangerous than leaving it in place. Microscopic fibers, undetectable by the human eye, can remain suspended in air or re-circulated through heating systems, causing continuous exposure.
